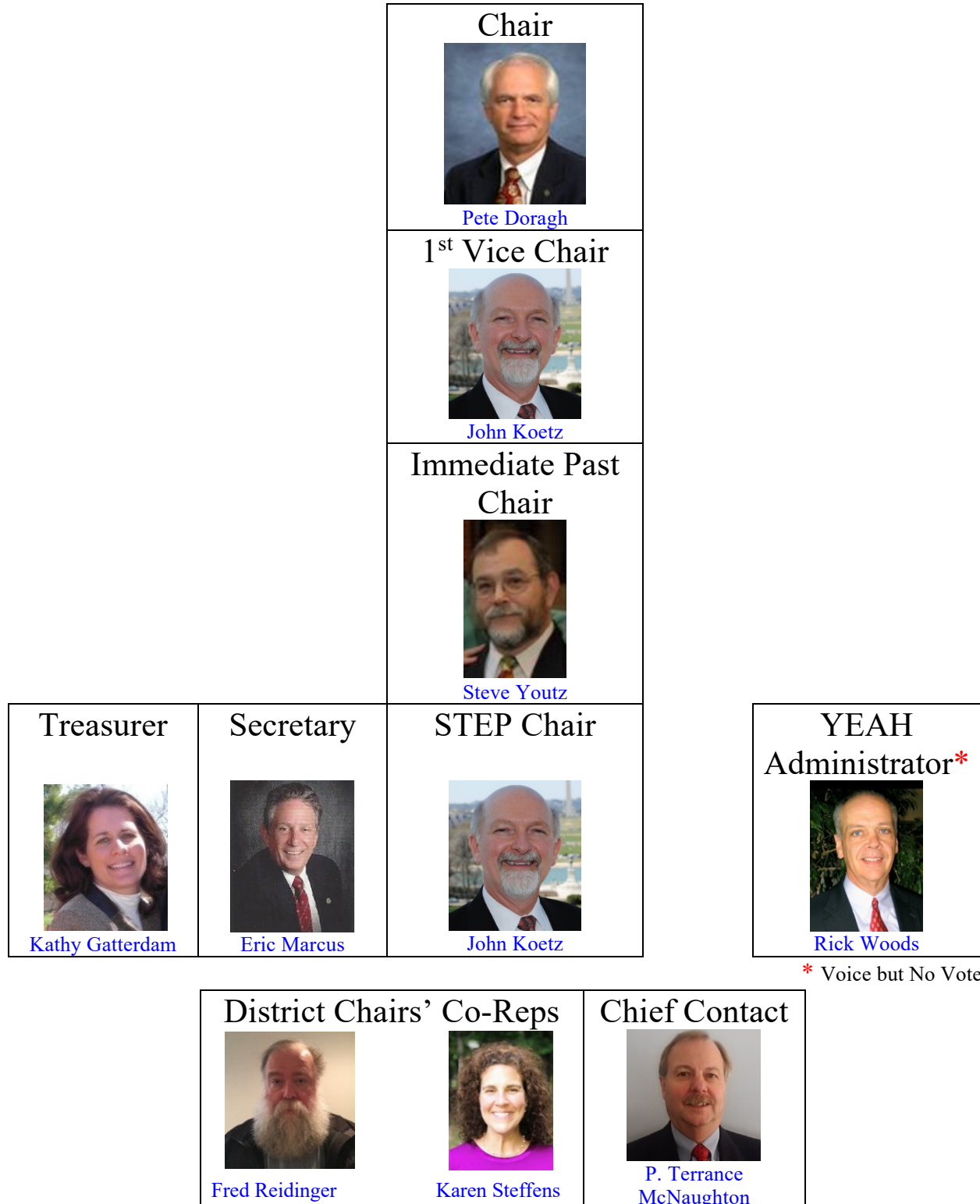

District Structure



